This Memorandum of Understanding is made on August 1, 2022

BETWEEN

CT Institute of Management & IT, Jalandhar, Punjab, a Private Higher Education Institution *OR* deemed to be University, approved by bearing registration certificate number 134, and hereinafter referred to as **"INSTITUTE"**.

AND

RADISSON Hotel Jalandhar GT Road, BMC Chowk, Sehdev Market, Jalandhar, Punjab 144001 hereinafter referred to as **"Radisson"**) collectively referred to as **"Parties"**

Whereas this Memorandum of Understanding (hereinafter called **"MOU"**) sets out the understanding of the Parties' intention to collaborate with each other.

OBJECTIVE

CT Institute of Management & IT, Jalandhar, Punjab and **Radisson Hotel Jalandhar**, desiring to enhance learning opportunities for students and to promote mutually beneficial linkages, agree to the establishment of a partnership for students pursuing the diploma / degree in Hospitality Management on the terms set out below.

1. Background:

- The parties have agreed to collaborate towards enhancing the learning experience of students studying Hospitality Management and therefore create a highly employable graduate.
- The purpose of the MOU is to define the basis on which scope of services offered will be articulated with the basic curriculum of **CT Institute of Management & IT, Jalandhar, Punjab** in accordance with the University requirements.
- The Parties agree that, except for **CT Institute of Management & IT, Jalandhar, Punjab** and **Hotel Jalandhar**, a person who is not a party to this agreement shall not have any rights to enforce any term of this agreement.
- The provisions stated in this MOU are statements of intent only. This is not a binding agreement

between the Parties (save for the confidentiality provisions below), and no such agreement establishing the binding obligations of the Parties and is approved by the relevant authorities of each Party.

2. Scope of the MOU

This Memorandum of Understanding formalizes an intent by both parties to collaborate and jointly undertake work as listed below

- a. **Student internships:** shall extend internships for deserving students pursuing UG programs at **CT Institute of Management & IT, Jalandhar, Punjab** from time to time based on a rigorous selection methodology. Students shall be governed by a contract to be signed between them and **Hotel Jalandhar**.
- b. **Internship** includes On the Job Training, ODC and any other training (full time / part time) as required and mutually acceptable between the Parties.
- c. **Placement of Students in India:** The Hotel will extend first preference in recruitment to qualified students of **CT Institute of Management & IT, Jalandhar, Punjab** at the entry level position or any applicable existing opportunity in Radisson Hotels in India only.
- d. **Faculty Development:** The Hotel shall offer opportunities for Faculty Development through Guest Lectures / Faculty Visits at its premises for faculty members of **CT Institute of Management & IT, Jalandhar, Punjab**
- e. **Financial commitment:** There is no financial commitment on the part of **CT Institute of Management & IT, Jalandhar, Punjab** to take up any program mentioned in the MOU.

3. Students Role and Responsibility

- a. Students are responsible to attend all normal curriculum classroom, practical training, projects, presentations relating to their diploma / degree program within **CT Institute of Management & IT, Jalandhar, Punjab** as well as all guest lectures, internship and industrial trainings, projects, presentations, coaching workshops organized by **CT Institute of Management & IT, Jalandhar, Punjab** or as defined under the MOU. (Provided it does not clash with their approved study plan).
- b. The selected students will have to accept the internship / industrial training and placement at the Hotel and location allocated to them. This is for Radisson Hotels in India only.
- c. The selected students will have to accept the final placement offering them entry level positions or any applicable existing opportunities at the Hotel and location allocated to them. This is for

Radisson Hotels in India only.

- d. Students will always have the responsibility to carry the good brand name of both **CT Institute of Management & IT, Jalandhar, Punjab** and The Hotel on and off campus. The students will abide by the policies and procedures of The Hotel during internship /placement.

3. Duration & Termination

- The MOU shall commence on _____ and continue for a period of 2 years unless terminated before that time in accordance with this clause. The parties may at any time by agreement in writing extend the duration of this Agreement.
- Either party may terminate this Agreement by giving to the other not less than 1 month notice in writing.
- Upon termination of this MOU each party shall cease using the name and/or logo of the other and parties undertake to discontinue use of the program materials.
- **Non-Exclusive Agreement:** The parties of this Agreement acknowledge and agree that this Agreement shall not be exclusive in any respect

4. Others

- Each Party hereby agrees to indemnify, defend and hold the other harmless from any loss, liability, costs or damages arising from actual or threatened claims or causes of action resulting from the gross negligence or intentional misconduct of such party or its participating students, respective officers, directors, employees, agents, members or, provided that such individuals are acting within the scope of their employment or agency, as applicable.
- Each Party agrees that any misconduct/ misbehavior /indiscipline by the participating students will only attract disciplinary action against the student in personal capacity, which may result in permanent debar from placement procedure. Under no circumstances, such event will result in the Termination of this MOU or any action against **CT Institute of Management & IT, Jalandhar, Punjab**.
- Where any unforeseen circumstances or causes beyond the control of **Radisson Hotel Jalandhar**, cause or threaten major disruption to its operations or any provision of this Understanding by that party or otherwise make fulfillment of the Student Internship/ Placement difficult (including but not limited to industrial disputes or the implementation of any disaster

plan), The Hotel must, at its earliest possible opportunity, notify the other of its intention to defer or cancel the Student Internship/ Placement.

- **Intellectual Property:** All intellectual property brought by Each Party to the training program contemplated under this MOU remains in the ownership of that Party. Use of logos, trademarks, service marks or other entity identification must be agreed in writing by Each Party. For avoidance of doubt, neither Signatory shall use logos, trademarks, service marks or other identification of **Radisson Hotel Jalandhar**, unless it is authorized in writing by representatives of Radisson India likewise use of **CT Institute of Management & IT, Jalandhar, Punjab** logo on any document, website will have to be pre-approved from **CT Institute of Management & IT, Jalandhar, Punjab**.
- **No assignment or subcontracting:** Both Parties acknowledges and agrees that Ownership of all Intellectual Property created, discovered, brought into existence or otherwise acquired by Either Party, as a result of, for the purposes of, or in connection with the Student placement/Internship program or this Agreement and all other rights in respect of such IP, shall vest exclusively in the designated Parties.

5. Disputes

- The parties shall attempt to resolve in good faith any dispute arising between them out of the operation of this MOU. If the dispute cannot be resolved informally, it shall be referred to Director of **CT Institute of Management & IT, Jalandhar, Punjab** and Name of the General Manager, **Radisson Hotel Jalandhar**.
- The parties agree to co-operate in dealing with or defending any claim by a third party arising out of the operation of this MOU.

6. Law and Jurisdiction

- This MOU shall be governed by and construed in accordance with the laws of India. Any dispute arising out of the operation of this MOU shall be finally settled by arbitration upon terms mutually agreed on by both parties.





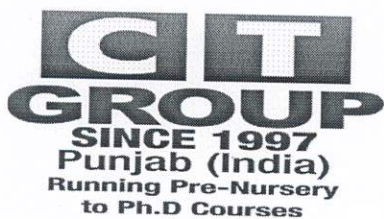

This MoU may be amended only with the written mutual consent of the institutions. Either institution shall have the right to unilaterally terminate this MoU at any time without assigning any reasons therefore by giving a one month's notice to the other institution.

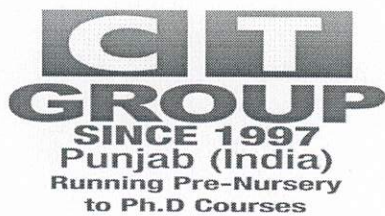
RELATIONSHIP

AND

Hyatt Regency, Amritsar MBM Farms, Grand Trunk Rd, Rajinder Nagar, Maqbool Pura, Amritsar, Amritsar Cantt., Punjab 143001 hereinafter referred to as "**Hyatt Regency**") collectively referred to as "Parties"

Whereas this Memorandum of Understanding (hereinafter called "MOU" sets out the understanding of the Parties' intention to collaborate with each other.

OBJECTIVE

CT Institute of Management & IT, Jalandhar, Punjab and **Hyatt Regency, Amritsar**, desiring to enhance learning opportunities for students and to promote mutually beneficial linkages, agree to the establishment of a partnership for students pursuing the diploma / degree in Hospitality Management on the terms set out below.

1. Background:

2. Scope of the MOU

- a. **Student internships:** shall extend internships for deserving students pursuing UG programs at **CT Institute of Management & IT, Jalandhar, Punjab** from time to time based on a rigorous selection methodology. - e. **Financial commitment:** There is no financial commitment on the part of **CT Institute of Management & IT, Jalandhar, Punjab** to take up any program mentioned in the MOU.

3. Students Role and Responsibility

- a. Students are responsible to attend all normal curriculum classroom, practical training, projects, presentations relating to their diploma / degree program within **CT Institute of Management & IT, Jalandhar, Punjab** as well as all guest lectures, internship and industrial trainings, projects, presentations, coaching workshops organized by **CT Institute of Management & IT, Jalandhar, Punjab** or as defined under the MOU. (Provided it does not clash with their approved study plan).
- b. The selected students will have to accept the internship / industrial training and placement at the Hotel and location allocated to them. This is for Radisson Hotels in India only.
- c. The selected students will have to accept the final placement offering them entry level positions or any applicable existing opportunities at the Hotel and location allocated to them. This is for Radisson Hotels in India only.

- d. Students will always have the responsibility to carry the good brand name of both **CT Institute of Management & IT, Jalandhar, Punjab** and The Hotel on and off campus. The students will abide by the policies and procedures of The Hotel during internship /placement.

3. Duration & Termination

- Upon termination of this MOU each party shall cease using the name and/or logo of the other and parties undertake to discontinue use of the program materials.
- **Non-Exclusive Agreement:** The parties of this Agreement acknowledge and agree that this Agreement shall not be exclusive in any respect

4. Others

- Each Party hereby agrees to indemnify, defend and hold the other harmless from any loss, liability, costs or damages arising from actual or threatened claims or causes of action resulting from the gross negligence or intentional misconduct of such party or its participating students, respective officers, directors, employees, agents, members or, provided that such individuals are acting within the scope of their employment or agency, as applicable.
- Each Party agrees that any misconduct/ misbehavior /indiscipline by the participating students will only attract disciplinary action against the student in personal capacity, which may result in permanent debar from placement procedure. Under no circumstances, such event will result in the Termination of this MOU or any action against **CT Institute of Management & IT, Jalandhar, Punjab**.
- Where any unforeseen circumstances or causes beyond the control of **Hyatt Regency, Amritsar**, cause or threaten major disruption to its operations or any provision of this Understanding by that party or otherwise make fulfillment of the Student Internship/ Placement difficult (including but not limited to industrial disputes or the implementation of any disaster plan), The Hotel must, at its earliest possible opportunity, notify the other of its intention to defer or cancel the Student

Internship/ Placement.

- **Intellectual Property:** All intellectual property brought by Each Party to the training program contemplated under this MOU remains in the ownership of that Party. Use of logos, trademarks, service marks or other entity identification must be agreed in writing by Each Party. For avoidance of doubt, neither Signatory shall use logos, trademarks, service marks or other identification of **Hyatt Regency, Amritsar**, unless it is authorized in writing by representatives of Radisson India likewise use of **CT Institute of Management & IT, Jalandhar, Punjab** logo on any document, website will have to be pre-approved from **CT Institute of Management & IT, Jalandhar, Punjab**.
- **No assignment or subcontracting:** Both Parties acknowledges and agrees that Ownership of all Intellectual Property created, discovered, brought into existence or otherwise acquired by Either Party, as a result of, for the purposes of, or in connection with the Student placement/Internship program or this Agreement and all other rights in respect of such IP, shall vest exclusively in the designated Parties.

5. Disputes

- The parties shall attempt to resolve in good faith any dispute arising between them out of the operation of this MOU. If the dispute cannot be resolved informally, it shall be referred to Director of **CT Institute of Management & IT, Jalandhar, Punjab** and Name of the General Manager, **Hyatt Regency, Amritsar**.
- The parties agree to co-operate in dealing with or defending any claim by a third party arising out of the operation of this MOU.

6. Law and Jurisdiction

- This MOU shall be governed by and construed in accordance with the laws of India. Any dispute arising out of the operation of this MOU shall be finally settled by arbitration upon terms mutually agreed on by both parties.

7. Amendment

This MOU may be modified or amended if the amendment is mutually agreed and made in writing and is signed by authorized representatives of the Parties.
